Thank you for your application for registration as a Senior Road Safety Auditor.

The aim of registration is to have on record a listing of suitably skilled and experienced road safety auditors for selection to undertake road safety audits. To be eligible for registration as a Road Safety Auditor the applicant must satisfy (a) and (b) of the following criteria, and to be eligible for registration as a Senior Road Safety Auditor, the applicant must satisfy (a), (b) and (c) of the following criteria:

- (a) a minimum of five years relevant experience in road design, traffic engineering, road safety engineering or other closely related road safety discipline;
- (b) successful completion of a road safety audit training course, approved and recognised by a State Road Authority; and
- (c) participation in at least five road safety audits of which at least three must be design stage audits.

Based on the information in your application, you satisfy the criteria for **Senior Road Safety Auditor** and have been registered on the database as such.

Please note that to remain on the register; you will be required to certify the maintenance and experience in road safety audit and the participation in at least one road safety audit per annum.


